- **Chinatown**— It is one of the largest in North America. In 2011 it was named the Canadian Glamorous Historic. The *Millennium Gate* on Pender Street was built in 2000 for China Town's blooming economy. The *Sam Kee Building*, built in 1913, narrowest Commercial in the world's front-to-back depth is only 6 ft (1.8 m).
- **Gas Town**— Known for its whistling *Steam Clock* and mix of souvenir shops, indie art galleries and decor sores in Victoria Building
- **Canada Place**— Site for 1986 World Expo.; home of Vancouver Convention Center, Pan Pacific Hotel, Vancouver World Trade Center, Cruise Ship Terminal and the virtual flight ride *FlyOver Canada*
FlyOver Canada (Optional) A virtual ride attraction, it utilizes state-of-the-art technology to give you the feeling of flight. You will hang suspended, feet dangling, before a 20-metre spherical screen while our film whisks you away on an exhilarating 8-minute journey across Canada, from east to west. Special effects, including wind, mist and scents, combine with the ride's motion to create an unforgettable experience
- **Canada Winter Olympic Park**— Take pictures of the *2010 Winter Olympic Cauldron*.
- **Stanley Park** -- The largest city park in Canada cover 1,000 acre with forest, totem poles and the most spectacular view from *Prospect Point*.
- **Capilano Suspension Bridge (Optional)** — The bridge hanged 70 meters above a river where you may find ancient pine trees, at the same time you can stroll along the *Cliff Walk* which takes you through rainforest vegetation on a series of unobtrusive cantilevered and suspended walkways jutting out from the granite cliff face above Capilano River to previously unexplored areas of the park.
- **Queen Elizabeth Park** - It is the highest point in Vancouver (152 m above sea level), which makes for spectacular views of the park, downtown Vancouver, and the mountains that line the North Shore.
